The candidates who have not passed NCVT Exam or Physical Fitness Test (Pole Climbing) were not allowed for written test / are disqualified for selection as per the condition of GUVNL circular dtd. 05.01.2016.

Further, there are many candidates who have scored identical marks. As per the precedent and in terms of GSO-156 these candidates have been selected in order of their date of birth i.e. the older candidate has been placed ahead of younger ones. Those candidates, who are within the age limit on the day of pole test i.e. 30.09.2018 were called for test.

This selection panel will be valid upto 24.01.2020. Next selection shall be drawn when the present select list gets exhausted/fresh vacancies occur.
