Himachal Pradesh govt. is inviting HP Beti Hai Anmol Yojana 2020 application form through online as well as offline mode. People can now download Beti Hai Anmol Yojana Application Form PDF at himachalforms.nic.in and can even apply online at the edistrict.hp.gov.in portal. This scholarship scheme has been launched after taking inspiration from the central govt's Beti Bachao Beti Padhao Abhiyan to encourage women education.

In this Beti Hai Anmol Yojana 2020, govt. provides scholarship of Rs. 300 to Rs. 1200 to girl students who have passed 12th class and wants to study further. By providing financial assistance to girls in the form of scholarship, HP govt. wants to encourage them to pursue higher education.

If your family comes in Below Poverty Line (BPL) category, then 2 girls of your family can take benefits of this scheme.

All the girl students who have completed their 12th standard and are pursuing B.A, B.Com, B.Sc, Engineering, Medical, Law courses can get this scholarship.

 All the applicants can download this offline application form, fill it and submit it to the concerned authorities along with the supporting documents.

After submitting the Beti Hai Anmol Yojna application form PDF to nearby Lok Mitra Kendra, Anganwadi and CDPO office, the concerned authority will approve the form.

How to Apply Online for HP Beti Hai Anmol Yojana

In case the applicant girl child wants to apply online for Beti Hai Anmol Yojna, then follow the process below:-

STEP 1: Firstly visit the official HP Online Seva Portal at

http://edistrict.hp.gov.in./pages/staticSite/serviceList.xhtml

STEP 2: At the homepage, click at the "Women and Child Welfare Department" link and then the list of services of that department will open as shown below. Click at the link below "Apply" section:-

STEP 3: In the new opened window, click at the "Sign Up" tab for new users registration. Upon clicking the Sign Up link, the HP Beti Hai Anmol Yojana online registration form will appear as shown below:-

STEP 4: Here enter all the details in the HP Beti Hai Anmol Yojana online registration form and click at the "Register" tab to complete the registration process. Afterwards, applicants can login to apply online for the scheme. The Beti Hai Anmol Yojana Login page will appear as below:-

STEP 5: Here applicants can enter the User ID, password, user type, captcha and click at the "Submit" button. The fill the remaining details in the application form.

After submitting the completed Beti Hai Anmol Yojna application form online, the form will reach to the concerned authorities for subsequent approval.

List of Documents Required for HP Beti Hai Anmol Yojna

Here is the complete list of documents required for HP Beti Hai Anmol Yojna 2020:-

- Aadhaar Card as Identity Proof
- Income Certificate
- Age Certificate as Date of Birth Proof
- Bank Passbook Copy
- BPL Ration Card
- Residence Certificate as a proof of being Bonafide Himachali
- Letter from Head Master of the School of the applicant (in case applicant is studying)

All the girl children who are born after 10 July 2010 can avail benefits of scheme till they study in class 12th. BPL family girls have no restriction on age for availing the benefits of the scheme.

Amount of Beti Hai Anmol Yojana Scholarship

The state govt. of Himachal Pradesh provides Rs. 5,000 to girls studying in undergraduate level or other equivalent courses and are belonging to BPL category.

What is Beti Hai Anmol Yojana

Beti Hai Anmol Yojana is for those girl candidates belonging to the below poverty line category. 2 girl children of a single family can take scheme benefits. The state govt. deposits the Rs. 10,000 scholarship amount in Post Office / Bank account of girl child when they are born. Girls studying upto 12th standard are also given assistance of Rs. 300 to Rs. 1200 for purchase of books and dresses. BPL category Girls studying at undergraduate level or other equivalent courses are given Rs. 5,000 per annum.

The main purpose of the Scheme to encourage education of the girl child for BPL families, and this scheme would provide assistance up to 2 girl child of the BPL family. This scheme aims to make the girl self- reliant with necessary financial assistance and education. Assistance would be given at the time of the birth of the girl child and then an annual scholarship would be given to the girl child.

This scheme is for girls of BPL families up to two girl children. After their birth, the department deposits rupees 10,000 per girl child in the post office/ Bank account. These girls get scholarship ranging from Rs. 300 to Rs.1200 from first to 12th Class for their books/dresses etc. The progress report is mentioned in the latest tweet on the official CMO Himachal Twitter Handler:-
